Trust Deed Variation

The King's College Foundation (**Foundation**) was established on the terms set out in a Trust Deed dated 17 September 1980, as amended from time to time since (**Trust Deed**).

The Trusts Act 2019 (Act) came into force on 30 January 2021. The Act replaced the Trustee Act 1956 and the Perpetuities Act 1964 with the objective of making trust law more accessible, including by clarifying core principles and essential obligations of trustees.

The Board of Management (**Board**) has, subject to Member approval, updated the Trust Deed to align it with the requirements of the Act (and other recent legislative changes, including the Charities Amendment Act 2023) and to generally update the Trust Deed. The key changes are set out below.
